The Bone and Joint Decade 2006 Patient Advocacy Seminar and World Network Conference

Global attention on bone and joint health converged in *Durban, South Africa*, from November 1-4, 2006 when delegates of the *Bone and Joint Decade Annual World Network Conference* and the *International Patient Advocacy Seminar* came together to cultivate strategies for the prevention of bone and joint disorders in both the developed and developing world. "*Keep People Moving: Strategies for the Prevention of Bone and Joint Disorders*"

was the theme of the global forum, at which more than 40 countries were represented by 120 delegates, including government officials, doctors, researchers and patients.

The BJD World Network conference was a key meeting for the Decade for two reasons. First, the draft version of *the BJD Global Standards of Care Documents on Osteoporosis/Hip Fractures and Pain* which was initiated at the 2005 World Network Conference in Ottawa, Canada, was presented. The document on Hip Fracture and osteoporosis was read by Assoc Prof Kristina Åkesson, member of the BJD International Steering Committee (ISC). The document was adopted at the Network Conference and will be submitted for publication in January. The Pain document was presented by Prof Nic Walsh, member of the ISC, and the leading principles were approved by the delegation. The document will be further revised and also be submitted for publication.

Secondly, Prof Lars Lidgren, chairman of the ISC, presented the *BJD Strategic Plan* 2006 – 2010 and Beyond. The map for

The South African Deputy Minister of Health, Hon Mrs Nozizwe Madlala Routledge, officially welcomed the delegates. Both The national and provincial Ministries provided financial support for the conference.

A few of the members of the BJD International Steering Committee were able to be involved in the South African NAN meeting giving presentations and in that way highlighting the Bone and Joint Decade's international role to the delegates from South Africa.

Exclusive eLecture by Dr Mats Brittberg, Associate Professor and a member of the Cartilage Research Unit, Department of Orthopedics Surgery, at Gothenburg University in Sweden. Dr Brittberg's research has been focused on cartilage repair, with the unique focus on cartilage regeneration using in vitro expanded autologous chondrocytes. NATIONAL ACTION NETWORK NEWS

AUSTRALIA: The Australian NAN will host the 2007 BJD World Network Conference. The dates are now confirmed: 10 – 14 October, 2007 and the venue will be the Courtyard Marriott Resort on the Queensland Gold Coast. AUSTRIA: On October 25th, 2006, the Austrian NAN held a charity gala for the BJD in a historical place, the 'Schloss Belvedere', in Vienna. Some presentations on the importance of prevention of musculoskeletal disorders as well as the cooperation between the different disciplines were held, followed by a classical concert. Many experts in the field, executives from pharmaceutical companies and from the Medical University of Vienna participated. The revenue of the event will be used for the musculoskeletal research cooperative of the Medical University of Vienna which was recently established between the departments of orthopaedics, traumatic surgery, physical medicine and rehabilitation, neurology and rheumatology. This musculoskeletal research cooperative will be one of the research focuses of the Medical University of Vienna for the rest of the Decade.

CANADA: The Canadian National Action Network continues to work on the five priorities identified for the second half of the Decade:

- 1. Develop and implement a wait list strategy to improve access to hip and knee surgery.
- 2. Develop and implement an osteoporosis strategy to enhance the level and consistency of osteoporosis care in Canada.
- 3. Develop and implement a musculoskeletal education strategy to enhance the training of health professionals
- 4. Train new clinical investigators with an interest in MSK research
- 5. Optimize patient involvement in the Bone and Joint Decade.
- 1. Wait List Strategy:

November 19, 2006, the Canadian NAN convened a meeting of leading orthopaedic surgeons and Musculoskeletal (MSK) stakeholders to work on developing a plan for addressing the MSK surgical wait lists in Canada.

2. Osteoporosis Strategy:

The Ontario government has committed \$5MM each year to this strategy. Osteoporosis Canada is responsible for implementing certain facets of the Ontario Strategy - the Ministry contracts with Osteoporosis Canada, the Ontario Orthopaedic Association and other agencies for various aspects of the overall Strategy. The Ministry of Health and Long Term Care of Ontario has engaged the Ontario Orthopaedic Association, and its osteoporosis consultant, Dr. Steven Richie, to provide local orthopaedic support for one key component of the program - to place osteoporosis coordinators in Ontario fracture clinics for post fracture osteoporosis care. Dr. Bogoch is in contact with the Osteoporosis Society and has seconded a key staff member part time to assist with the implementation.

At the same time, a group led by Osteoporosis Canada, and supported by the Canadian and Ontario Orthopaedic Associations is seeking support from the federal government to roll out a Canadian Osteoporosis Strategy. BJD Canada fully supports this initiative and request for government funds.

3. Musculoskeletal (MSK) Education Strategy:

Dr.Wadey is presently in discussions with various stakeholders getting their input at the early stages of the Core Curriculum program. The Canadian MSK Core Curriculum was accepted for publication in the Journal of Rheumatology and will be published in the new-year. Commencing January 2007, she will be relocating to The University of Toronto to assume an academic appointment at the Holland Orthopaedic and Arthritic Institute and Sunnybrook Health Sciences Centre as a Surgeon Investigator. One of her first research priorities will be the launch of this educational initiative.

4. Training new MSK investigators:

In collaboration with USBJD, Canada hosted the fourth Young Investigators' Workshop in Vancouver, British Columbia, in September 2006. In attendance were 17 first time participants and 14 returning participants who received instruction and mentoring regarding how to successfully secure research funding. Their pool of skilled mentors has grown to 24. The program evaluations indicated a high level of satisfaction with the workshop.

The call for applications has gone out for the next workshop, which will take place in Chicago, Illinois, USA. Applications are welcome from Canadian and American early career investigators.

5. Optimize patient involvement in BJD:

Colleen Maloney represented Canada at the international BJD Conference in Durban, South Africa. "For me, as a first timer at a BJD conference it was intriguing to listen and learn about the concerns and the initiatives of my international colleagues on issues ranging from building a positive working relationship with the media to developing awareness of bone and joint health. Interesting too were the similarities and challenges we face particularly in the area of fundraising. While the World Network Conference that followed the Patient Advocacy Meeting was interesting, there was no more poignant or thought provoking than "Rehabilitation in a Rural Environment." Ms. Mariske Bezuidenhout, a physiotherapist in South Africa included photographs with her presentation that allowed the delegates to travel with her as she administered to patients in rural areas."

The Vice President of the Hungarian Academy of Sciences, Professor Norbert Kroó, opened the Arthritis Day for an audience of 280 patients, professionals, representatives of the Ministry of Health and National Health Insurance, and the media.

Dr Géza Bálint, the National coordinator outlined the economical and social burden of musculoskeletal diseases, as well as the Decade's initiatives in this respect. Prof Gyula Poór, President of the Association of Hungarian Rheumatologists spoke about the efficacy and cost-savings of early diagnosis and treatment of arthritis, while Prof. Miklós Szendröi, orthopaedic surgeon, and BJD Ambassador spoke about the cost-efficacy of total hip and knee endoprothesis implantation.

A press conference and a presentation of a new patient-information book, published on the occasion of Arthritis Day followed the program. Arthritis Day ended with a reception. For more information please contact <u>bjd@t-online.hu</u>

IRELAND: The Irish BJD launched "Straighten Up Ireland" on World Spine Day, October 16th 2006. The simple exercise program was publicised in national and local newspapers and on T.V.

The Irish Department of Health and Children was asked to support the initiative but did not due to the short notice given so the program was fully funded by the Chiropractic Association of Ireland (CAI). Despite the lack of backing from the Department of Health, the program was a huge success with thousands of Irish back pain sufferers attending "Straighten Up" demonstrations around the country.

It was felt that if "Straighten Up" were adopted on a permanent basis by BJD as an ongoing health promotion, it might help garner more government support for the initiative in countries like Ireland. Governmental support will be needed to affect long term lifestyle changes in an increasingly sedentary populace. The Irish BJD intends to promote "Straighten Up" on an ongoing basis and would welcome feedback from our worldwide and European partners in particular who may have an interest in pushing this initiative in the new year.

The Irish BJD is now establishing a National Action Network and we will report on that in coming Infoletters.

KOREA: The Korea Research Council of Rheumatism (KRCR) has joined the Bone and Joint Decade and initiated a commitment for a five-year programme promoting Better Korean Bone and Joint Health. This programme aims to increase national awareness, and to promote advancement in research regarding treatment and prevention of musculoskeletal diseases.

On Oct 19, 2006, the KRCR had a meeting in Seoul, Korea for the Rheumatology Symposium on "Healthy Joints and Well-Being Life". The symposium was the result of year long activity of the 2006 Rheumatism Campaign. The symposium aimed at establishing measures to prevent and treat rheumatic diseases, working toward a better quality of life. The target groups were health policy decision makers, media, key network clinicians, and patient societies. The issue of disability resulting from the musculoskeletal diseases was also discussed. The meeting concluded that close collaboration and persistent efforts between the groups interested in promoting Bone and Joint Health are essential for continuation of the initiative.
