





On behalf of the European Association for Behavioural and Cognitive Therapies – EABCT – and the organising Dutch Association for Behavioural and Cognitive Therapy –VGCt- it is a great pleasure to invite you to the EABCT Congress in The Hague from 10 – 13 September 2014.

Over the years a gap has developed between research into experimental psychopathology and research into treatment in academic settings on the one hand and cognitive behavioural therapy in clinical practice on the other. The aim of this congress is to bridge this gap.



Programme

The scientific programme will cover a diverse range of topics including: the cognitive-behavioural treatment of addictive disorders, anxiety disorders, OCD and related disorders, mood disorders, eating disorders, psychotic disorders, personality disorders, child and adolescent mental health, treatment of the elderly, and behavioural medicine.

Innovation

Throughout these topics, the emphasis will be on evidence-based practice, training of evidence-based CBT practitioners, dissemination of results of clinically relevant studies, the pros and cons of technological innovations in CBT such as internet-based therapy, virtual reality treatment and use of gaming in therapy.

The scientific programme will span 3 days, 11 - 13 September 2014, and will include plenary sessions, keynote addresses, workshops, clinical master classes en meet the expert meetings, symposia, open papers, and poster sessions. Precongress workshops will be offered on Wednesday 10 September 2014. Precongress workshops are skill-based workshops led by internationally renowned practitioners in their field, and will cover a range of CBT applications at introductory, intermediate and advanced levels of training.

Congress delegates will hear outstanding clinical and scientific presentations on new developments in cognitive behavioural therapy for a broad mixture of disorders. The congress will provide an opportunity to meet old and new international colleagues and friends.

Speakers

The committee will provide a highly interesting scientific programme featuring influential researchers and clinicians from





around the world. Speakers who have already committed are Arnoud Arntz, Claudi Bockting, Thomas Ehring, Sheila Eyberg, Dirk Hermans, Emily Holmes, Wendy Silverman, Reinout Wiers and Martina Zwaan.

Submission

The official language will be English. Electronic submission of abstracts for symposia, workshops, panel debates, open papers and posters will be possibile from 1 September 2013 until 1 April 2014. All abstracts must be submitted in English. Delegates who are presenting must register for the congress before the presentation can be included in the programme. Each author can submit a maximum of 3 contributions as first author.

Early registration will start 1 October 2013.

The programme will be available online from 1 May 2014.



Scientific Committee Chair Prof.dr. Paul M.G. Emmelkamp



is full professor of Clinical Psychology at the University of Amsterdam and honorary member of the Dutch Association for CBT. He has contributed to a number of areas, incl. anxiety and personality, disorders, substance abuse

and dependence, ADHD, and forensic psychiatry. He has written and edited many books on research into a variety of clinical subjects. Further, he has written over 450 publications in peer reviewed journals or books.

Dr. Arnold A.P. van Emmerik

is researcher at the Department of Clinical Psychology of the University of Amsterdam.

He has published mainly on the diagnosis and treatment of PTSD. He is a member of the board of the Dutch Association for CBT.

He is a member of the board of the Flemish Association for Behavioural Therapy (VVGT), and is Associate Editor of Journal of Experimental Psychopathology.

is a clinical psychologist. He promotes, researches and teaches about short-term forms of (behavioural) therapy. He is currently working as director treatment issues at Indigo Zeeland. is assistant professor at the University of Amsterdam, Department of Developmental Psychology with focus on experimental research regarding developmental psychopathology.

About The Hague, the Netherlands
